Protecting customer privacy is vital to our business. By sharing our Privacy Policy, we trust that you will better understand how we keep your information secure and when we may share your information with third parties. At Behalf, you are covered by the terms and conditions and any privacy notices posted on this website.

Information that We Collect

We may collect any and all information ("Information") that is present within, associated with, or relates to this website, any other Behalf-branded website, and any Behalf-branded payment or financing product or service. This includes information about customers of Behalf products and the owners and other natural persons acting on behalf of customers (collectively, "you" for the purposes of this Privacy Policy). Information we collect may include, without limitation:

- Information collected when you interact with a Behalf website, such as your IP address, information about your device, your activity while in the Behalf website, your location when using a Behalf website, and similar information. This also may include data from cookies, web beacons, Flash objects, and/or pixel tags we use to collect information about your activity online, such as the time and duration of your visit to a Behalf site, the pages you viewed, and your response to a Behalf email or advertisement.
- Information you provide when applying for a Behalf-branded product or service, such as
 the information you provide when applying for a Behalf-branded account, information
 about transactions you make using a Behalf-branded account, and information you
 provide when you create and use an online Behalf account. This includes both
 information regarding you as a business entity and information regarding the natural
 persons associated with the business entity, including information such as your name,
 mailing address, phone number, Social Security number, business financials, and email
 address.
- Information that we obtain from third parties when you use a Behalf-branded product or service. This can include information from business and consumer reporting agencies, information from merchants that accept payments from a Behalf-branded account.

You authorize us to collect such Information and for us to use it for any lawful purpose. Without limiting the foregoing, (i) you authorize us to collect, store, and use information regarding your location when you interact within any Behalf website or apply for or use any Behalf-branded product or service; and (ii) if you are a natural person, you authorize us to

obtain consumer reports about you when you apply and while you have a Behalf-branded account.

If you create an online Behalf account, you may log into that account to review and request changes to your online account information. Third parties we work with also may collect information about you, including personally identifiable information such as your online activities over time and across different websites when you use a Behalf website or your use of a Behalf-branded product or service.

How We Protect Your Information

We take our responsibility to protect the privacy and confidentiality of the information we receive about very seriously. How We Share Your Information

- Our vendors, service providers, and others in connection with providing Behalf-branded products or services to you.
- Any governmental authority when required by law, or upon a request or demand from such authority.
- Merchants accepting payments from a Behalf-branded account, including information such as if you have applied for financing under a program serviced or administered by Behalf, the status of your application, information about your account, and other information about you and your account.
- Business and consumer reporting agencies.
- Other third parties, including without limitation, for marketing by such third parties.

You authorize us to share Information as described above. Without limiting the foregoing, if you are a natural person, you authorize us to share consumer report information about you with third parties to the extent reasonably necessary to facilitate a transaction requested or initiated by you.
